# **One Time Incentives**

# 1. Fixed Capital Rebate

#### Benefits for Textile Park Developers

- Financial assistance @50% of total project cost with maximum limit of INR 10 crore
- Financial assistance @50% of project cost of Hostel/ Dormitory Housing for domicile workers maximum up to INR 2 crore
- Assistance @25% of the investment towards purchase of equipment and machinery to a maximum up to INR 20 lakh

#### Capital Subsidy

# **Recurring Incentives**

1. Skill Development/ Training Incentive

• Employment Generation Subsidy: Upto INR 36,000/- per year per employee for 5 year or 20% of the SGST deposited, whichever is less to all category of Textile enterprises.

## 2. Interest Cost Subvention

• Interest Rebate /Subsidy Interest subsidy @ 3% per annum, maximum up to INR 15 lakh per annum
