One Time Incentives

Land Cost Rebate

- @50% of land cost will be reimbursed for land bought from State Government agencies
- @30% land subsidy in case of Gautam buddh Nagar

Fixed Capital Rebate

- @25% subsidy for plant and machinery subject to following limit and conditions:-
- Upto Rs 2 Cr for investment less than equal to Rs 10 Cr or min 50 employment
- o Upto Rs 10 Cr for investment more than Rs 10 Cr but less than Rs 50 Cr or min 200 employment
- Upto Rs 20 Cr for investment more than Rs 50 Cr but less than Rs 100 Cr or min 300 employment
- Upto Rs 40 Cr for investment more than Rs 100 Cr but less than Rs 200 Cr or min 500 employment
- Upto Rs 100 Cr for investment more than Rs 200 Cr or min 1000 employment
- @20% for silk reeling units with capital investment of minimum Rs 1 Cr

3. Stamp Duty Exemption

- @100% exemption (except in GB Nagar district)
- @75% exemption in GB Nagar district
- @100% exemption to Sericulture chaaki, koya production, threading units
- @100% exemption on land purchased for the development of infrastructure facilities

4. Other Incentives

 @15% margin money as capital subsidy for units for rearing of chaaki worm, koya production, reeling and spinning in sericulture sector, for SC/ST and @20% for women

Recurring Incentives

1. SGST Reimbursement

- Net SGST reimbursement subject to an annual upper limit of 25% of fixed capital investment (Land, Building, other Construction and Plant & Machinery for period of 10 years
- o @90% for MSME textile units
- @80% for Mega and Super-Mega
- Non-MSME units
- @90% in Poorvanchal and Bundelkhand
- o @75 % in Madhyanchal and Pashchimanchal
- o @60 % in GB Nagar district

2. Interest Cost Subvention

- @7% on loan taken for procurement of TUFS eligible plant & machinery for period of 7 years subject limit of INR 1.5 Cr per year and INR 75 lakh in GB nagar district
- @5% on loans taken for developing infrastructural amenities for period of 5 years subject to cap of INR1.00 Cr per unit
- @5%, on loans taken for research, quality improvement and development of textile products by textile industry associations and groups of textile industrial units for a period of 5 year

3. Electricity Duty Rebate

• 100% exemption from electricity duty will be given to new units for 10 years

4. Other incentives

EPF Reimbursement:

• 50% for 5 years for new textile units which provide employment to minimum 100 workers

• 60% for 5 years for units which provide employment to minimum 200 workers

5. Export Promotion

- For export promotion freight reimbursement will be provided to new units as follows:
- 75% for first 2 years
- 50% for next 2 years
- 25% for the 5th years
